The amount previously reported in the 10-D filed on August 17, 2009 was incorrect due to a delay in processing certain Bankruptcy related claims on certain accounts in July 2009, and defaults related to such accounts were excluded from the required reporting. As a result, several metrics in this report were impacted, including Defaulted Accounts during the Month, Annualized Default Rate, Series 2002-CC Defaulted Amount and Shared Excess Finance Charges of Series 2002-CC. The Defaulted Accounts reported for July 2009 were understated by \$3,611,346.49 and the Series 2002-CC Defaulted Amount reported for July 2009 was understated by \$2,725,852.73.
