Under the Amended and Restated Pooling and Servicing Agreement dated as of September 30, 1993, as amended and restated as of August 1, 2002, January 13, 2006, March 23, 2007 and July 1, 2007, and as further amended by the First Amendment, dated as of March 1, 2008 (as amended and supplemented, the "Agreement"), among Capital One Bank (USA), National Association, as Servicer, Capital One Funding, LLC, as Transferor, and The Bank of New York, as Trustee (the "Trustee"), Capital One Bank (USA), National Association as Servicer is required to prepare certain information each month regarding current distributions to Certificateholders and the performance of the Capital One Master Trust (the "Trust") during the previous month. The amount previously reported in the 10-D filed on October 15, 2009 was incorrect due to a delay in processing certain Bankruptcy related claims on certain accounts in September 2009, and defaults related to such accounts were excluded from the required reporting. As a result, several metrics in this report were impacted, including Defaulted Accounts during the Month, Annualized Default Rate, Series 2002-CC Defaulted Amount and Shared Excess Finance Charges of Series 2002-CC. The Defaulted Accounts reported for September 2009 were understated by \$ 4,672,731.35 and the Series 2002-CC Defaulted Amount reported for September 2009 was understated by \$3,603,312.93.
