## Explanation of Responses:

- These restricted stock units vest in 1/3 increments beginning on February 15, 2015 and annually thereafter.
- Each restricted stock unit will be settled in cash based on the Company's average fair market value of the underlying shares of common stock over the fifteen trading days preceding the vesting date.
- These restricted stock units will vest in 1/3 increments beginning on February 15, 2016 and annually thereafter.
- These restricted stock units will vest in 1/3 increments beginning on February 15, 2017 and annually thereafter.
- Each restricted stock unit will vest on January 1, 2017 and will be settled in cash on February 15, 2017 based on the Company's average fair market value of the underlying shares of common stock over the fifteen trading days preceding the settlement date.
- This option became exercisable in 1/3 increments beginning on January 26, 2012 and annually thereafter.
- This option became exercisable in 1/3 increments beginning on February 21, 2009 and annually thereafter.
- This option became exercisable in 1/3 increments beginning on March 2, 2008 and annually thereafter.
