5. This award is reported net of 338 units automatically withheld by the Company to satisfy the reporting person's tax obligations.

6. These restricted stock units will vest in 1/3 increments beginnings on February 15, 2017 and annually thereafter.

7. Each restricted stock unit will vest on January 1, 2017 and will be settled in cash on February 15, 2017 based on the Company's average fair market value of the underlying shares of common stock over the fifteen trading days preceding the settlement date.

8. This option becomes exercisable in 1/3 increments beginning on February 15, 2017 and annually thereafter.
