### Item 1 Description of Registrant's Securities to be Registered.

The securities to be registered hereby are depositary shares of Capital One Financial Corporation (the "Company"), each depositary share representing a 1/40<sup>th</sup> ownership interest in a share of the Company's Fixed Rate Non-Cumulative Perpetual Preferred Stock, Series N, par value \$0.01 per share (the "Preferred Stock"), with a liquidation preference of \$25 per depositary share (equivalent to \$1,000 per share of Preferred Stock). The descriptions set forth under the sections "Description of Preferred Stock" and "Description of Depositary Shares" in the prospectus supplement dated July 26, 2021, as filed with the Securities and Exchange Commission (the "Commission") on July 27, 2021 pursuant to Rule 424(b) under the Securities Act of 1933, as amended, to the prospectus (the "Base Prospectus") included in the Company's automatic shelf registration statement on Form S-3 (No. 333-254191), as filed with the Commission on March 12, 2021, and the descriptions set forth under the sections "Description of Preferred Stock" and "Description of Other Securities" of the Base Prospectus are incorporated herein by reference.
